Special and/or sensitive personal data that we process

For what purpose and on what basis we process personal data

Puur & Simpel processes your personal data for the following purposes:

- Saving and publishing reviews

Automated decision-making

**How long we keep personal data**

Puur & Simpel only provides to third parties and only when necessary for the performance of our agreement with you or to comply with a legal obligation.

Cookies, or similar technologies, that we use

Puur & Simpel only uses functional cookies.

View, modify or delete data

You have the right to access, correct or delete your personal data. In addition, you have the right to withdraw your possible consent to data processing or object to the processing of your personal data by our company and you have the right to data portability. This means that you can submit a request to us to send the personal data that we hold about you in a computer file to you or another organization named by you. If you wish to exercise your right of objection and/or right to data portability, or if you have other questions/comments about data processing, please send an itemized request to info@puurensimpel.nl. To make sure that the request for inspection is made by you, we ask you to send a copy of your ID with the request. In this copy, black out your passport photo, MRZ (machine readable zone, the strip of numbers at the bottom of the passport), passport number and Citizen Service Number (BSN). This is to protect your privacy. Puur & Simpel will respond to your request as soon as possible, but in any case within four weeks. Puur & Simpel would also like to point out that you have the possibility to file a complaint with the national supervisory authority, the Authority for Personal Data.
